An internationally recognized thought leader, Dr. Grigas collaborates with the DC and the international think-tank community. She serves as a nonresident Senior Fellow at the Atlantic Council and an advisory board member at the McKinnon Center for Global Affairs, Occidental College, the Vilnius Institute for Policy Analysis and formerly at the LNG trading company LITGAS.

Agnia has fifteen years of experience in business development and strategic advisory for multinational corporations and government institutions. She has testified for the Senate Committee on Energy and Natural Resources on American LNG exports to Europe and served on the foreign policy team of Hillary Clinton's 2018 Presidential campaign. Previously she was an energy and FDI advisor to the Lithuanian Ministry of Foreign Affairs. She started her career as a financial analyst at JPMorgan and subsequently advised on emerging markets for Eurasia Group, Barclays Bank, and other Fortune 100 companies.

Dr. Grigas is an in-demand keynote speaker, and a frequent media contributor. Her articles and commentary have appeared in WSJ, NYT, CNN, BBC, Forbes, Newsweek, Bloomberg, Reuters, Foreign Affairs, Foreign Policy, and others.

#### Political Risks and Economic Opportunities in a Globalized World

With a volatile international environment and the rise of transnational risks and conflicts, understanding political and geopolitical risk has become more important than ever for corporations and organizations with a global reach. Military conflicts, rise of populism, pandemics, food insecurity, inflation, energy insecurity, climate change... #### Russia-Ukraine: A Regional Conflict with Global Consequences

The Russia-Ukraine conflict which erupted in a full-blown war in 2022 has upended the post-Cold War era. As author of TIME magazine's Top 9 books on Russia, "Beyond Crimea: The New Russian Empire" (Yale UP), Dr. Grigas demonstrates how this conflict is reconfiguring geopolitical alignments. European maps are re-drawn. Markets are divided. The energy and food sectors are in flux. The future of NATO, the European Union, Russia, Ukraine, and Eurasia is in question. What can we expect in the conflict? What are the implications? Why does this matter for governments, industries, and citizens worldwide?

#### **Geopolitical Balancing and Alignment**


Can countries still balance – politically and economically – between the United States and China? Until recently in a world dominated by the superpower of the United States (some would argue a declining power) and the rising superpower of China (in terms of its economy and population), many countries opted to balance in the middle. The Ukrainian Russian war drew red lines between Russia and the West. Moreover, this war has highlighted the growing global divide between the democracies and autocracies. Dr. Grigas discusses what can smaller, developed or developing nations expect in their efforts to balance be-tween the superpowers and rising superpowers in a globalized but at the same time divided world.

#### **Globalized and Digitalized Education**


