He co-founded SoftKey Software Products (later The Learning Company), which became a reference in educational software. After scaling the business globally, the company was sold to Mattel in 1999, marking one of the most notable exits in its sector.

Following this success, Kevin pivoted toward investing and media. He founded several investment platforms — including O’Leary Ventures and O’Shares Investments — and has invested in dozens of high-potential companies.

His rise to international recognition came with his role as “Mr. Wonderful” on Shark Tank, and earlier as a judge on Dragons’ Den, where he became known for his blunt honesty and sharp business acumen.

Today, as a keynote speaker, Kevin draws on decades of entrepreneurial success, investment experience, and financial expertise to guide audiences and organizations toward strategic growth, financial intelligence, and entrepreneurial mindset.

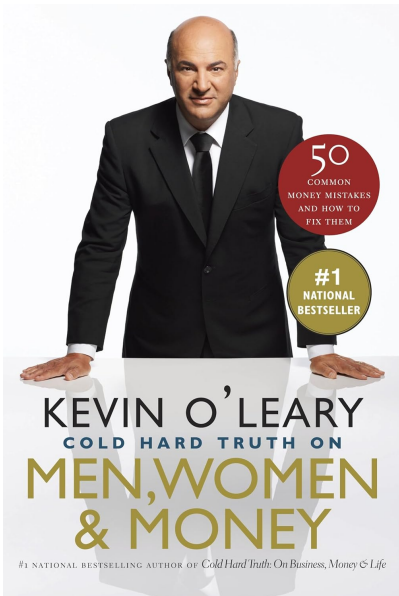

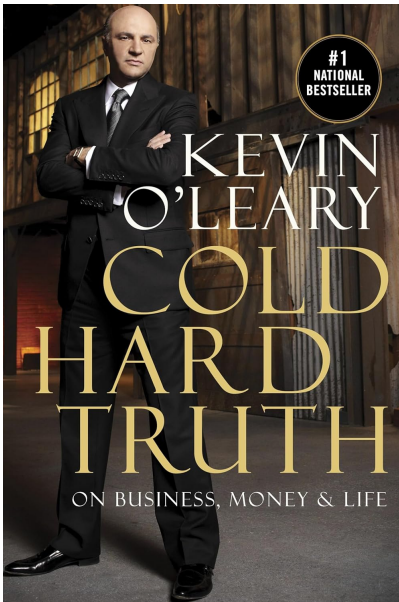

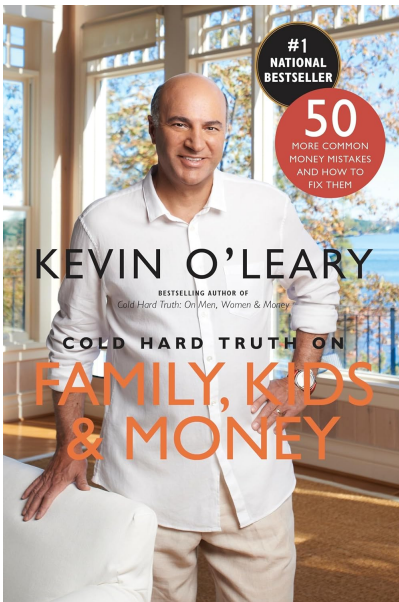
